Tailored Art Museum Itineraries - Travelers visiting cities around the world often find themselves intimidated at the thought of visiting an art museum, especially in locations where they do not speak the native language. The BAAC is committed to creating tailored itineraries for novice museum visitors, helping them explore world-famous museums that feature Baroque art and artists. The itineraries will provide background for each of the most famous Baroque art pieces at the museum, where the pieces are located as well as things to think about while observing the piece. This initiative aims to guide interested parties through renowned collections, enhancing their understanding and appreciation of Baroque Art. In 2024, we produced two custom itineraries that were viewed over 300 times.

Website and Social Media Accounts - The BAAC dedicates significant efforts to maintaining an educational website and various social media accounts to promote and enhance the public's understanding of Baroque art and artists. This initiative provides detailed information about prominent Baroque artists and their renowned artworks. Additionally, this program will also translate to English posts from European museums who typically do not post in English, where the automatic translation by the social media platform is not available. In 2024, the BAAC social media accounts earned 50 followers and posted 34 times.
